HANFORD FEDERAL FACILITY AGREEMENT AND CONSENT ORDER (TRI-PARTY AGREEMENT) CHANGE PACKAGE C-07-07, "TRANSFER AND ASSIGNMENT OF SELECTED WASTE UNITS TO THE 200-CW-3 OPERABLE UNIT"


The purpose of this letter is to transmit the Tri-Party Agreement Change Package C-07-07, "Transfer and Assignment of Selected Waste Units to the 200-CW-3 Operable Unit" to the U.S. Environmental Protection Agency (EPA) and the State of Washington Department of Ecology (Ecology) for approval.

Approval of this change package authorizes the transfer of six waste units from the 200-MG-1 Operable Unit to the 200-CW-3 Operable Unit and the assignment of three waste units to the 200-CW-3 Operable Unit. These waste units are outside the 200 East/West Areas and the Comprehensive Land-Use Plan core zone around the 200 Areas. Transfer and assignment of these waste units will facilitate remediation and closure of the 200 North Area.

The original change package is being provided initially to EPA for approval. EPA is then requested to forward the change package to Ecology for approval and subsequent return to this office.
