Status of Work and Progress to Date

Work was initiated on the 200-BP-1 Phase 1 and 2 Feasibility Study during fiscal year 1990. The following deliverables were submitted as required by Task Order Numbers G-90-34 and S-90-16:

- Initial Planning Package - Milestone 4.3 (Task 2.3.1).
- "Preliminary 200-BP-1 Operable Unit Remedial Action Objectives and General Response Actions" - Milestone 4.4 (Tasks 2.1.1 and 2.1.2).
- "Preliminary Draft 200-BP-1 Operable Unit Applicable or Relevant and Appropriate Requirements - Milestone 4.5 (Task 2.2.4).
- "Preliminary Draft Data Needs for the 200-BP-1 Phase 1 and 2 Feasibility Study" - Milestone 4.5 (Task 2.2.5).
- "Preliminary Draft-Identify Volumes or Area of Contaminated Media at the 200-BP-1 Operable Unit" - Milestone 4.6 (Task 2.1.3).

In addition to the above deliverables required by the Task Orders, we have been evaluating RI data provided by WHC as required by Task 2.2.5, and have attended the monthly Unit Managers Meetings as required by Task 2.3.3. As part of the RI data review, Northland Geophysical Company under subcontract to Golder Associates Inc. prepared a report, "Review of Geophysical Testing Investigations for the 200-BP-1 Operable Unit, Geosciences Group Westinghouse Hanford Company Richland, Washington."

Percent Complete - All deliverables required by the Task Orders for fiscal year 1990 are 100% complete.

Schedule - All milestones have been completed on schedule.
