Summary of Discussion and Commitments/Agreements**1. Approval of Past PMM Minutes**

The August 18, 1995, September 12, 1995, and October 12, 1995 meeting minutes have been reviewed, but not approved. Approvals will be handled via the mail. Since November 30, 1995 is the final meeting, the review and approval of these minutes will also be handled via mail.

2. Status Action Items

3. Status Closure Activities**- Status of Certification**

WHC (J. G. Adler) stated that the certification of closure had been sent to Ecology on October 27, 1995 and asked if Ecology had received. Ecology (S. E. McKinney) confirmed that Ecology had received the certification of closure. Ecology also stated that the certification was being accepted and that the response was about to be mailed.

- Status of Future Meetings

Ecology (S. E. McKinney), RL (E. M. Mattlin), and WHC (J. G. Adler) discussed the status of future meetings. It was determined that there are no additional closure issues to discuss since Ecology will be accepting the Certification of Closure for the 304 Concretion Facility. The closure of the 304 Concretion Facility has been completed. No additional PMMs are required.

4. New Business**- What happens after Certification of Closure is accepted.**

RL (E. M. Mattlin), WHC (J. G. Adler, R. A. Ruck III), and Ecology (S. E. McKinney) review what occurs after Ecology accepts the Certification of Closure: The Part A Form 3 will be revised to indicate the unit has been closed. This is then submitted back to

Ecology. Ecology then will enter the closure of the 304 Concretion Facility into the EPA's RCRIS database. Ecology also will revise the Hanford Site RCRA Facility Permit to show that the 304 Concretion Facility has been closed.

- Status of Lead Letter

Ecology (S. E. McKinney) discussed issuing a letter that would discuss, for the record, how the anomalous lead value was handled. RL (E. M. Mattlin) stated that such a letter would be OK.

- Change in Nomenclature

Please note that the most recent revision of the *Hanford Federal Facility Agreement and Consent Order* (Tri-Party Agreement) has changed Unit Manager's Meeting to Project Manager's Meeting
