Dear Mr. Smith and Mr. Lindholm:

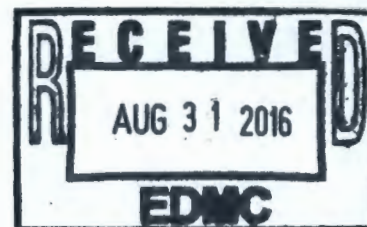
Ecology has reviewed your response letters and enclosures, received on June 15, 2016 and August 22, 2016 (References 2 and 4). These letters included corrective actions for items of non-compliance identified in Ecology's June 25, 2015, inspection of the Liquid Effluent Retention Facility and Effluent Treatment Facility (LERF/ETF). As of August 22, 2016, Ecology determined areas of non-compliance 1, 4, 5, 6, 7 and 8 have been addressed (References 2 and 4). Areas of non-compliance 2 and 3 have revised corrective actions and response times per the July 19, 2016, Ecology letter (Reference 3).

Ecology will work with you to complete all associated permit actions by November 20, 2016, (i.e. 90 days from receipt of Reference 4). However, if more time is needed to resolve needed permit actions, Ecology can extend the date when corrective actions, listed in the July 19, 2016, Ecology letter (Reference 3) and the LERF/ETF Inspection report (Reference 1), are due. If more time is required, you may request an extension in writing to me, before the compliance action deadline. The request should include the reasons an extension is necessary and a proposed date for completion.

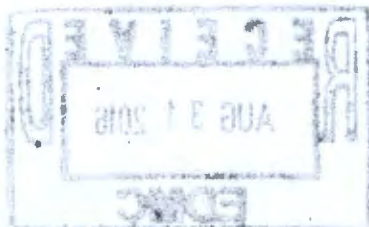
