-Status NOD Comments (On Schedule)

WHC (D. M. Korematsu-Olund) stated that work continues on preparing the Data Evaluation Report on the sampling analytical results. WHC (D. M. Korematsu-Olund) asked if Ecology had reviewed the laboratory analysis results from the soil sample splits that they took. Ecology (F. Ma) stated that the review of the data results should be completed this week, by their chemist.

-Permit Conditions

WHC (D. M. Korematsu-Olund) inquired if Ecology has officially responded to RL and WHC permit conditions comments. Ecology (F. Ma) said that Moses Jaraysi of Ecology had prepared responses to RL and WHC concerns. WHC (F. A. Ruck) inquired if the public had submitted any comments to the permit conditions? Ecology (F. Ma) stated that Ecology had not received any public comments at this time.

WHC (F. A. Ruck) proposed that once the demolition sites were clean closed and the fences were taken away, that the sites be left as they currently exist, without additional grading. WHC (F. A. Ecology could then send a letter accepting the sites appearance. Ecology (F. Ma) agreed that the two demolition sites should be kept as they currently exist without further grading.
