SAMPLING AND ANALYSIS OF 100 AREA SPRINGS, REVISION 1 (DOE/RL-92-12)

The U.S. Department of Energy, Richland Operations Office (RL), is submitting the subject document to the U.S. Environmental Protection Agency (EPA) and the State of Washington Department of Ecology (Ecology) for information only. This submittal is in response to EPA's request for official transmittal of the document, and to address EPA's concern that the subject document is not available in the Hanford Federal Facility Agreement and Consent Order administrative record.

RL agreed to produce "Sampling and Analysis of 100 Area Springs" Rev. 1, in response to EPA's comments on Rev. 0 of the same document. The subject document incorporates RL's resolution of regulator comments on Rev. 0 as agreed in April 1992 by the 100 Area operable unit management leads for RL, EPA, and Ecology. RL provided the subject document (Rev. 1) to EPA and Ecology in May 1992. Over the past two years since publication in May 1992, Rev. 1 has received wide distribution to other federal, state, and local government agencies and interested public on request. The Westinghouse Hanford Company personnel logged the subject document into the Administrative Record on July 2, 1992, and its identification number is 21727.
