

HANFORD NATURAL RESOURCE TRUSTEE COUNCIL
RESOLUTION NO. 99-01

WHEREAS, the Hanford Natural Resource Trustee Council (Council) determined the need for a comprehensive Hanford Site 100 Area Assessment Plan (Plan) that would determine current injury to natural resources caused by the releases of hazardous substances, and ultimately restore and protect these resources from future exposure; and

WHEREAS, the first volume titled *Hanford Site 100 Area Assessment Plan, Volume I: Columbia River Aquatic Resources* is the first phase of a comprehensive process; and

WHEREAS, Volume I of the Plan investigates only current injuries to aquatic resources in the Columbia River from River Mile 385, located in the Hanford Reach, out to the Pacific coast, and primarily focuses on river segment, River Mile 385 to McNary Dam, of the assessment area since this is the area of documented current exposure; and

WHEREAS, Volume I is designed to be in general accordance with the Natural Resource Damage Assessment Regulations, 43 CFR Part 11, promulgated by the U.S. Department of the Interior; and

WHEREAS, Volume I of the Plan identifies potential investigative studies to evaluate current injury of Columbia River aquatic resources that could be used to establish remedial cleanup criteria, establish/confirm exposure pathways, and aid the trustees in the need for restoration of injured resources; NOW, THEREFORE BE IT

RESOLVED that the Council approves the content of the final *Hanford Site 100 Area Assessment Plan, Volume I: Columbia River Aquatic Resources*.


