

Re: Central Waste Complex Dangerous Waste Storage Inventory Request for the
Operating Record

Dear Mr. McCormick:

The purpose of this letter is to request the submittal of a complete waste storage inventory, by area, for low-level mixed waste and transuranic mixed waste at the Central Waste Complex (CWC).

Washington Administrative Code (WAC) 173-303-380 (1) and (2) requires the owner or operator of a facility to keep this information in a written operating record. This operating record must include waste type, quantity, and type of management. Under WAC 173-303-380(3), all required records must be furnished on request to the Department of Ecology (Ecology).

WAC 173-303-300(6) further requires that a facility operator be able to track a waste as it moves through the facility, providing for a record of locations within the facility where wastes are stored.

Enclosed is a schematic of the CWC provided by the United States Department of Energy as part of Ecology's March 2012 dangerous waste inspection. Please provide the required waste storage inventory, including a piece count by area designations shown on this schematic. For example, areas are designated on this schematic as Storage Area A, Storage Area B, etc. Also provide the inventory by building number as referenced on the schematic.







CWC Outside Storage Area B


Flammable And Alkali Metal Waste Storage Modules
