This form documents agreement among parties listed authorizing classification of the subject unit as Closed Out, Interim Closed Out, No Action, RCRA Postclosure, Rejected, or Consolidated. This form also authorizes backfill of the waste management unit, if appropriate, for Closed Out and Interim Closed out units. Final removal from the NPL of No Action and Closed Out waste management units will occur at a future date.

Description of Current Waste Site Conditions:

(Summarize status of investigation/remediation of the waste sites.)

In 1981, contaminated pigeon feces were found in the vicinity of the 204-S Waste Unloading Facility, 221-U and several other facilities in 200 West and 200 East Area. The source of the contamination was determined to be the water accumulating in the 204-S tank basin. The 204-S tank basin was decontaminated to background radiation levels, and the affected area around 221-U was chained off and posted as a radiation area. Bird screens were installed to keep the pigeons out of 204-S. The occurrence report states that a plan for clean up of contaminated pigeon feces shall be developed. In 1983, the 203-S, 204-S and 205-S facilities were demolished, which eliminated the source of the contamination. The area around the 203-S, 204-S facilities, including the railcar Unloading Facility, have been surface stabilized. The areas described in the original Occurrence Report are no longer marked or posted. This site was reclassified to No Action in 2004.

Basis for Reclassification:



(For closeout, reference supporting documentation, as listed in Table 3.)

Facility radiological surveys from 1986, 1987 and 1988 for 202-S, 222-S, 221-U, 211-U and 271-U have been reviewed. Several mention pigeon feces with readings of background level or less than detectable. There is no evidence that any areas at U Plant or REDOX continue to be posted because of contaminated pigeon feces. It is recommended that this Unplanned Release site be Reclassified from No Action to Rejected.
