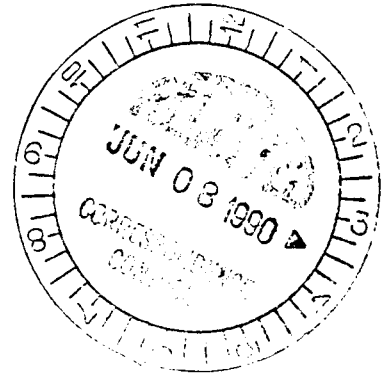

STATUS OF HANFORD FEDERAL FACILITY AGREEMENT AND CONSENT ORDER CORRECTIVE ACTIONS SUPPORTING MAJOR MILESTONE M-23-00

This letter is to inform you of the status of the Hanford Federal Facility Agreement and Consent Order corrective actions identified under the Major Milestone M-23-00, Permitting and Closures of Treatment, Storage, and Disposal Units. The scope of this notification is to include only those actions under Milestone M-23-00 that were scheduled for completion during April 1990.

Only one action supporting closure of Milestone M-23-00 was scheduled for completion during April 1990. The action, to ensure that B Plant personnel who work with dangerous waste receive appropriate training, is in support of Interim Milestone M-23-18, Complete Interim Status Corrective Actions at B Plant, and was completed on April 26, 1990.

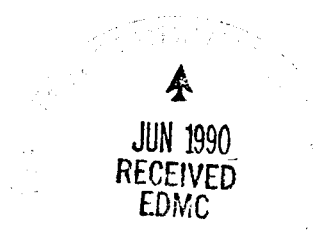
