## Summary of Discussion and Commitments/Agreements

## 1. Approval of Past UMM Minutes.

September minutes were signed on October 19, 1994 by the Ecology Unit Manager during a Hanford Site visit. As agreed to by Unit Managers, no October meeting was scheduled.

2. Status of Action Items  
- NONE3. Status Closure Activities  
- Clean Closure Evaluation Report

WHC (Mr. S. N. Luke) indicated that a letter transmitting the *2727-S Nonradioactive Dangerous Waste Facility Clean Closure Evaluation Report* (CCER), WHC-SD-EN-TI-242, Rev. 0, to Ecology is at RL for concurrence. However, final release of the letter has been delayed due to concerns with the CCER legal disclaimer. Two report pages will be changed out in replacing the disclaimer. Except for the legal disclaimer, the report that was advance issued to Ecology in July, 1994, will be identical to the transmittal copy.

Mr. R. E. Cordts of Ecology indicated that he was ready to provide comments on the advance issued CCER based on the assumption that the version transmitted by RL, except for the legal disclaimer, would be identical. Ecology comments are as follows:

1. Provide Ecology with copies of the following documents that were referenced in the report or otherwise pertain to closure:
  - sampling field logbook (EFL-1038),
  - Sampling authorization form (SAF) 92-262 for sampling required by the closure plan, and
  - SAF 92-309 for sample of the oil-spill,

2. Figure 1 showing sample locations identified 2 X-ray Fluorescence (XRF) locations with the same sample number B07528.
3. Ecology asked how rejected selenium and thallium data would be used to meet the requirement for such data.
4. Nine polycyclic aromatic hydrocarbons (PAHs) were detected in sample B07556. Although these did not individually exceed their respective PQLs or the MTCA Method A cleanup level for PAHs (1 ppm), their total PQLs when added together, could exceed the required cleanup level.
5. Ecology identified the report as being logical and informative.

WHC (Mr. S. N. Luke) indicated that WHC would provide the requested information as rapidly as possible and would follow up with a letter of confirmation of the transmittal of this information.

**- Notification Letter for Initiation of 2727-S Closure**

As required by the Hanford Facility RCRA Permit (RCRA Permit), written notification to Ecology that 2727-S NRDWS Facility closure activities have begun was provided by RL in a letter on October 27, 1994. WHC (Mr. F. A. Ruck) indicated that if a copy of the letter did not arrive soon to the Ecology Unit Manager, a copy could be FAXed to Ecology.

**- Removal of Barrels and Demolition Debris**

WHC (Mr. S. N. Luke) indicated that activities were underway to transport the barreled waste soils and piping remnants now at the site to Hanford's Central Waste Landfill and to dispose of it there as nondangerous waste. The option of returning this waste to the 2727-S site as backfill was discussed within the CCER; however, its removal from the site was seen as being beneficial in clarifying the closure picture.

**4. New Business:**

A copy of field logbook (WHC-N-629 1), that documented site demolition after sampling would be provided to Ecology.

**5. Set Next Meeting Date**

The next Unit Managers Meeting was scheduled for 12:30 PM, December 15, 1994, in Richland.
