NPDES PERMIT NO. WA-00374-3 MONTHLY MONITORING REPORTS

In accordance with the reporting requirements of our NPDES permit, enclosed please find the monitoring reports for the month of January 1989. An apparent excursion was observed and noted on January 24, 1989, at discharge 005. The limit for total suspended solids at discharge 005 is 30 mg/L. A sample analysis, completed on February 6, 1989, indicated 35mg/L on a sample taken at 9:15 a.m. on January 24, 1989. A verbal noncompliance notification was made to your office on February 7, 1989. The investigation of the incident determined that an improper sampling technique was used. The details of the excursions have been included in a noncompliance notification which was forwarded to your office on February 15, 1989.

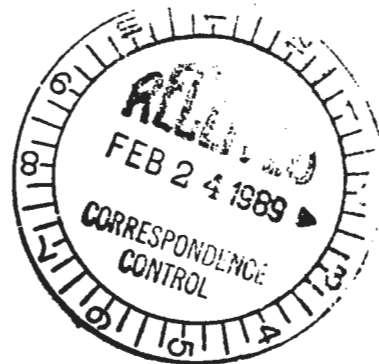
