**TPA-MP-14 Procedure Discussion**

EPA stated that the purpose for the MP-14 procedure was to get waste sites in and out of the WIDS system. Two years ago EPA determined the WIDS procedure needed to be updated regarding institutional controls. DOE and the contractors made revisions to the procedure. EPA agrees with the institutional control changes and is ready to sign. Ecology stated that the only issue is that their legal department has not reviewed the procedure. ORP has not yet seen the procedure. A meeting will be held next week to address the revised procedure. EPA would like to have approval by April 2006.

*Discuss the role of the IAMIT with regard to the role of the TPA Executive Committee*

EPA provided a handout concerning IAMIT responsibilities. The questions raised were:

- “Should we continue to use the IAMIT as a forum for discussion of issues related to cleanup at Hanford or more strictly follow TPA guidelines?”
- “Should we task IAMIT work groups to look at various issues and then have the work groups come back to the IAMIT for leadership.”
- “Should the informal IAMIT continue as a function that looks at big picture issues and reserve the Executive Session of IAMIT for resolving project disputes.”

Per the TPA Article XVI, 59 D, the IAMIT function is strictly dispute resolution. These questions need to be clarified at the IAMIT/Executive Committee level.

Ecology would prefer to bring the meetings back together. A portion of the afternoon meeting that is currently held could be open to anyone followed by a closed session where more formal dispute issues are heard. The formal portion would need to be documented with meeting minutes; the open portion would not require minutes. Disagreements up to some degree could be part of the open session and at some point they would be taken to the Executive Committee. A good example is the M-015 milestones. There are divergent expectations between DOE and Regulatory issues.

There was considerable discussion about the format of the IAMIT and Executive Committee meetings and whether or not minutes would be taken. It was determined that there would be one IAMIT meeting with minutes taken. The number and types of invitees (based on TPA requirements for the IAMIT vs. the Executive Committee) was still being negotiated.
