Otherwise, all of us on the applicable committees/work groups need to be involved in preparing any drafts.

For now, RL's comment is this - Due NRTC process must be followed in preparing the attached letter and finding. In addition, we left the last meeting agreeing that USGS and PNNL should review all three studies and make recommendations. This letter circumvents that entire review process and is therefore premature.
