**Summary of Discussion and Commitments/Agreements****1. Approval of Past UMM Minutes**

Unit Managers Meeting minutes for May 24, 1995, June 20, 1995, and July 18, 1995, have been approved and are awaiting signatures.

**2. Status Action Items**

No open action items.

**3. Status Closure Activities****-Status of Sampling and Analysis Activities**

WHC (ZC Knaus) stated the effort to order equipment necessary for decontamination activities was continuing. The HEPA-VAC has arrived, but a portable high-pressure wash machine has not. Also, a trailer was requested to be relocated at 105-DR as a field change room/office and is being setup. ZC Knaus added that a Professional Engineer has been selected to certify closure. The PE toured the 105-DR facility on August 4, 1995, and also will be present during decontamination activities.

ZC Knaus reported that the sandblasting of the burn vessel at 105-DR would occur during the second week of September 1995. He did not have an exact date for the start of removing the carbonates since the high-pressure sprayer had not arrived yet. As for the duration of the project, ZC Knaus said that he thought it would take about six months to complete all closure activities. Ecology (SE McKinney) requested that ZC Knaus take an action item to produce a schedule for activities related to carbonate removal.
