
Re: Remedial Investigation/Feasibility Study (RI/FS) Work Plan for Tanks/Lines/
Pits/Boxes/Septic Tanks and Drain Fields Waste Group Operable Unit, 200-IS-1
and 200-ST-1

The Washington State Department of Ecology (Ecology) and the United States Department of Energy have exchanged a series of correspondence (see enclosed) on the Remedial Investigation/Feasibility Study (RI/FS) Work Plan for Tanks/Lines/Pits/Boxes/Septic Tanks and Drain Fields Waste Group Operable Units, 200-IS-1 and 200-ST-1. After reviewing Revision 1 of Draft A of the RI/FS work plan, Ecology concludes that there are "major issues" with the document. Ecology suggests that we attempt to resolve the apparent impasse using the Dispute Resolution process as described in the Hanford Federal Facility Agreement and Consent Order.

The initial step in the Dispute Resolution process is a 30-day period of discussion at the Project Manager level. Ecology understands that because of other ongoing discussions about the 200-SW-1/2 RI/FS work plan, our agencies are mutually agreeable to deferring the start of that 30-day period until April 1, 2005. If that is not your understanding, please notify Ecology within 7 days of the date of this letter.
