DELEGATION OF REMEDIAL PROJECT MANAGER (RPM)/ON SCENE COORDINATOR (OSC) RESPONSIBILITIES FOR THE 200-MG-1, 200-MG-2, OPERABLE UNITS, 200 NORTH AREA RAILCARS, AND MULTI-INCREMENT SAMPLING PROGRAM CONDUCTED UNDER THE COMPREHENSIVE ENVIRONMENTAL RESPONSE, COMPENSATION AND LIABILITY ACT (CERCLA) AT THE HANFORD SITE

This letter is to notify the U.S. Environmental Protection Agency and State of Washington Department of Ecology that the U.S. Department of Energy, Richland Operations Office (RL) has delegated Remedial Project Manager (RPM)/On Scene Coordinator (OSC) responsibilities and authorities for the above-mentioned sites conducted under the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) on the Central Plateau of the Hanford Site to Frank Roddy. In addition, Al Farabee as the Federal Project Director for this workscope, is authorized to act on his behalf in that role.

This delegation has been made pursuant to the requirements of 40 CFR 300.120, which directs that the lead agency (RL) shall assign RPMs/OSCs to manage remedial and other response actions at National Priorities List CERCLA sites. These delegations are subject to the limits of project manager duties, roles, and responsibilities as described in 40 CFR 300.120.


