TRANSMITTAL OF THE SEMIWORKS SOURCE AGGREGATE AREA MANAGEMENT STUDY REPORT (AAMSR), REVISION 0


This letter transmits the Revision 0, Semiworks Source AAMSR to the U.S. Environmental Protection Agency (EPA) and the State of Washington Department of Ecology (Ecology).

The Semiworks AAMSR was prepared as a secondary document in accordance with the objectives of the Hanford Past Practice Strategy (DOE/RL-91-04) and the methodology and format for the AAMSR presented in AAMSR Chapter 1, which was submitted as interim milestone M-27-01.

The U.S. Department of Energy, Richland Operations Office (RL) transmitted the Draft A, Semiworks AAMSR for review and comment by EPA and Ecology on July 30, 1992. RL received EPA/Ecology's comments on September 14, 1992, and provided their dispositions on October 14, 1992. At a comment resolution meeting that occurred on November 20, 1992, to further discuss RL's dispositions, all of the regulators' comments have been satisfactorily resolved with minor text changes.

Since the Semiworks Draft A was prepared while reformulating the redlined Draft B of other source AAMSRs, the Semiworks Draft A included: 1) finalized generic text based on U, Z, S, and T AAMSRs regulator comments, 2) reduced Section 2.3.2 repetitive text regarding Single Shell Tanks, 3) a generic physical conceptual model in Section 4.0, 4) implementation of the analogous site concept in Section 9.0, 5) a summary of physical and chemical setting for analogous groupings in Section 9.0, and 6) minor changes as a result of Westinghouse Hanford Company technical editing. These changes were reviewed in the U Plant Draft B by the regulators and finalized based on the September 1, 1992, U Plant Draft B and the September 24, 1992, Past Practice Unit Managers' Meetings. They have been applied to all AAMSR including the Semiworks, Revision 0.
