## FFTF PROJECT MEETING MINUTES

Project Managers Meeting  
825 Jadwin/Room 340/700 Area  
Richland, Washington

September 24, 2009

- I. Approval of May 28, 2009 FFTF Project Meeting Minutes (Ecology/DOE-RL/CHPRC)
  - A. The meeting minutes were approved.
  
- II. Administrative Issues
  - A. Doug Chapin (RL) stated that some administrative changes to the 400 Area waste management unit (WMU), under the Hanford Facility RCRA Permit, have been signed by RL. Jeff Ayres (Ecology) stated that he recently signed off on those administrative changes. Mr. Chapin noted that there is a new Mission Support Contract (MSC), which is the integration steward for the Hanford Site Facility RCRA Permit.
  
- III. Project Specific Issues
  - A. Mr. Chapin stated that the FFTF facility is in surveillance and maintenance (S&M) mode. S&M will be performed once a year in March. A major part of S&M will be to comply with semi-annual inspections of two active containerized storage areas [Building 403 (Fuel Storage Facility or FSF) and the Interim Storage Area] of mixed waste (e.g., piping, equipment, and components contaminated with elemental sodium and sodium hydroxide) associated with the 400 Area WMU, as governed by requirements of the Hanford Facility RCRA Permit.
  - B. For informational purposes, Mr. Chapin reported that three T-3 casks will be stored indefinitely on the 400 Area ISA pad, which is outside the fenced area. The training T-3 cask is not contaminated and is sitting in an enclosed trailer with sides but no top. The two T-3 casks used for transport are currently in Idaho and will be sent to the Hanford Site for storage. The transport casks are contaminated in the inside to low levels. The storage of the T-3 casks has no impact on the S&M aspect of FFTF. The T-3 supporting documentation is located in a storage module on the ISA.
  - C. Rick Bond (Ecology) inquired about the buildings in the 400 Area that are outside the FFTF Property Protection Area (PPA). Brian Dixon (CHPRC) responded that the buildings contain a recycle center and fleet maintenance shops, and due to the cost of relocating those facilities, they will continue to be operated. Sanitary wastewater from these buildings is discharged via a sewer line to the Energy Northwest sanitary sewer system. Mr. Chapin added that the MASF facility, which is inside the PPA, also discharges sanitary wastewater to Energy Northwest. Mr. Chapin noted that MASF is now part of the K Basins closure project ownership and no longer associated with FFTF.

Mr. Chapin added another point for information in response to Mr. Bond's inquiry about buildings outside the PPA. A DOE Environmental Assessment (DOE/EA-1668D) is being prepared. The EA will evaluate the impacts of D&D of the 22-plus buildings in the 400 Area outside the PPA under the River Corridor Project and the 90-plus buildings and structures in the 200 Area under the CHPRC project. Also included in the EA will be some scope relative to the North Slope and various land management unit sites. Mr. Chapin noted that this EA is not associated with FFTF.

- D. Al Farabee (RL) reported that the infrastructure people are considering reopening the FFTF septic tank and sewer line, which is outside the PPA 400 Area boundary. The septic tank would be used as a holding tank only, and the waste would be pumped out by a truck.

The sanitary wastewater is currently piped to Energy Northwest, and the savings would be \$73,000 per year if the septic tank is used instead of piping the wastewater. Mr. Chapin noted that this item is for informational purposes only and not associated with the FFTF project.

IV. Status of Previous Agreements and Commitments

- A. There were no previous agreements or commitments.

V. New Agreements and Commitments

- A. There were no new agreements or commitments.

VI. Near Term Schedules and Ongoing Activities (Milestones, TSD Unit)

A. Milestone Status

Mr. Chapin stated that all of the milestones, with the exception of M-92-09, are completed. Ecology has accepted completion of the milestones, and the correspondence is in place. Milestone M-92-09 is due September 30, 2018, and is an interim milestone under Milestone M-92-00, which outside of the FFTF project authority to address. Mr. Chapin provided Mr. Bond with a list of all the milestones. Mr. Bond noted that he was to check the status of Milestone M-92-10, and stated that it was closed in 2005.

B. Permit

1. Dangerous Waste

The dangerous waste permit was referenced under agenda item No. 2, administrative issues.

2. Wastewater Discharge Permit

Mr. Chapin stated that he is still working with Kathy Conaway (Ecology) on the ST4501 waste discharge permit on behalf of the K-Basins project, noting that the ST4501 permit has no association with FFTF. RL is providing assistance from a knowledge standpoint on the ST4501 permit. There are two options being considered for the waste discharge, which consists of the effluent water from the sludge simulation activities at MASF and a small discharge from the compressor. One option is to truck the wastewater to ETF, which would likely eliminate the need to modify the ST4501 permit; a second option is to discharge to the city of Richland.
