### TRANSMITTAL OF THE 2101-M POND CLOSURE PLAN, REVISION 2 (D-2-1)

The U.S. Department of Energy, Richland Operations Office (RL), and the Westinghouse Hanford Company (WHC) are submitting the 2101-M Pond Closure Plan, Revision 2, for approval by the State of Washington Department of Ecology (Ecology). In an Ecology letter to Mr. R. G. McLeod from Ms. E. A. Wiley "Clean Closure of 2101-M Pond," dated March 10, 1993, and from conversations during the March 10, 1993, Unit Managers' Meeting, RL and Ecology agreed that the pond is considered clean closed requiring no further action. This submittal is in compliance with the July 9, 1993, extension due date which was requested in a RL letter to Messrs. G. C. Hofer and R. F. Stanley from Mr. J. D. Bauer, dated April 28, 1993.

Changes required to revise the closure plan include numerous reference updates and appendix call out changes throughout the document.

- Section I, page I-2, lines 5 through 18, and page I-22, lines 5 through 8, have been reworded. New photographs of the 2101-M Pond have also been added.
- Section B, page B-1, the first paragraph of Section B-1 has been reworded to include the Phase II sampling. On page B-15, new text has been added on lines 28 through 30. In Section B-5g, B-5g(2) has been deleted and the rest of the section rewritten. The remaining sections altered in Section B include modifications to B-6b(3.2 and 3.3), B-6d(1), and new entries in B-6e.
- Section C has been revised.
- Section II has been revised according to the Notice of Deficiency comments with additional corrections to II-7 and II-10.

- The Appendices have been reordered to accommodate the new data. Appendices D-1 and F have been switched to B-4 and B-5, respectively. Appendices E-1 and E-2 have been switched to D-1 and D-2, respectively. Appendices D-2 and G have been switched to E-1 and F-1, respectively. Appendices D-3 and D-4 are new to this revision.


The large amount of data being reported necessitated separating the closure plan into two volumes. The second volume contains the actual data and associated information.


