Description/Justification of Change <p>The U.S. Department of Energy (DOE) and the State of Washington Department of Ecology (Ecology) are conducting a pilot activity for Land Disposal Restriction (LDR) reporting under the M-026-01 milestone series. For only the Calendar Year (CY) 2005 LDR reporting activities, this pilot activity will establish a Hanford LDR Summary Report. The Hanford LDR Summary Report will contain elements from the Hanford LDR Report considered to be important for reporting purposes. DOE and Ecology have determined through the monthly Project Manager Meetings which elements of the annual Hanford LDR Report should be reported in the CY2005 Hanford LDR Summary Report.</p> <p>The due date of the M-026-01P milestone and subsequent M-026-01 milestones are not being modified by the change request. After DOE submits the CY2005 Hanford LDR Summary Report and the primary document process is completed, DOE and Ecology will make a decision on the development of future Hanford LDR Summary Reports.</p>
