EPA and Ecology have requested that the Senior Field Office Manager RL (Mr. John Wagoner) prepare and send to Ecology and EPA senior management a letter referencing DOE proposed TPA Milestone M41-00 extension and enter into formal Tri-Party Agreement negotiations on the M41-00 milestone series and incorporate the M41-22 dispute resolution into said negotiations.
