Deactivation: Utility isolations were performed on the facility prior to removal of mobile office.

Decontamination and Decommissioning: Hazardous materials were removed prior to above-grade demolition (i.e., Splitting in half and hauling). Hazardous material removal and waste disposition was performed in accordance with Removal Action Work Plan For Central Plateau General Decommissioning Activities (DOE/RL-2010-33, Rev.0).

Demolition: MO-919 was hauled to ERDF for disposal in April 2015 per OWTF 200E-15-0083 and 200E-15-0084.


