Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes

The July Unit Managers' Meeting (UMM) was held by teleconference. Consequently, the Unit Managers' Meeting Minutes (UMMM) from May were not signed. The comment draft of the May UMMM was sent via cc:mail to Ecology (Mr. S. E. McKinney). There was no Unit Managers' Meeting held in June.

2. Status Closure Activities

-Closure Plan Transmitted to Ecology

On June 28, 1993, 105-DR LSFF Closure Plan, Revision 1 was transmitted to Ecology.

- Ecology review of Closure Plan

Ecology (Mr. S. E. McKinney) indicated that he had received the closure plan but, due to his work on the Tri-Party Agreement (TPA) Milestone negotiations, had been unable to review the document. He was unsure of when he would be able to look at the closure plan.

3. New Business

Ecology (Mr. S. E. McKinney) requested one new copy of the Closure Plan. Future correspondence with Ecology, Lacey must have the attachments (e.g. copies of closure plans, NOD response tables) sent directly to Mr. McKinney to avoid delay.

In response to a question raised by DOE-RL (Mr. R. N. Krekel), Ecology stated that ~~splitting~~ ^{modifying} SEM the Part A permit application would be more efficiently accomplished after the partial clean closure of the facility.

The next meeting was scheduled for Tuesday, August 24, 1993. The meeting is planned to be a video teleconference between Richland and Lacey, Washington.
