Dear Mr. McCormick:

The Department of Ecology approves the referenced Class 2 Modifications to the *Liquid Effluent Retention Facility and 200 Area Effluent Treatment Facility* (LERF/ETF) and the *Integrated Disposal Facility* (IDF) chapters of the Site-Wide Permit (reference).

The modification to LERF/ETF updates calculated tank volumes and emergency pumping information. The changes to tank volumes are based on calculations and do not result in a change in tank management practices at the facility. The changes to the emergency pumping information update the current emergency pumping plans for the unit.

The modification to IDF changes the monitoring schedule of the leak detection system. The pre-active life monitoring frequency schedule will change to quarterly and after major storms.

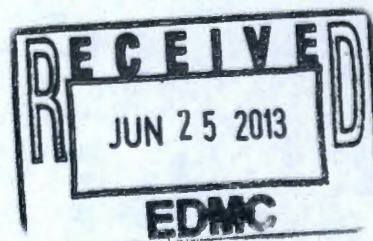
