PROPOSED PLAN FOR THE REMEDIATION OF THE 200-CW-5, 200-PW-1, 200-PW-3, AND 200-PW-6 OPERABLE UNITS, DOE/RL-2009-117, REVISION 0, AND FEASIBILITY STUDY REPORT FOR THE PLUTONIUM/ORGANIC-RICH PROCESS CONDENSATE/PROCESS WASTE GROUP OPERABLE UNIT: INCLUDES THE 200-PW-1, 200-PW-3, AND 200-PW-6 OPERABLE UNITS, DOE/RL-2007-27, REVISION 0

The U.S. Department of Energy, Richland Operations Office (RL), in agreement with the U.S. Environmental Protection Agency (EPA) is proposing a combination of alternatives to address contamination at waste sites in the Central Plateau of the Hanford Site. These alternatives are described in the Proposed Plan for the Remediation of the 200-CW-5, 200-PW-1, 200-PW-3, and 200-PW-6 Operable Units, DOE/RL-2009-117, Revision 0. The Proposed Plan also identifies a preferred alternative for implementation. This document is being transmitted by separate letter (11-AMCP-0169) in support of the 30 day public comment period (July 5, 2011, through August 5, 2011).


