Thank-you for your February 4, 1993, letter notifying the Confederated Tribes of the Umatilla Indian Reservation (CTUIR) about an upcoming meeting on natural resources trusteeship activities at the Hanford site.

As you are aware, the CTUIR retain treaty reserved rights to ceded lands associated with the Treaty of 1855. Hanford partially occupies lands ceded to the U.S. Government in the Treaty. The CTUIR are committed to addressing natural resources issues affecting their ceded lands and their treaty.

Hence, I am notifying you that the CTUIR are will participate in the April 15, 1993, meeting on natural resource trusteeship. However, the CTUIR reserve the right to determine their future participation in activities relative to this issue.
