Public Involvement Determination for M-013-00N

The State of Washington, Department of Ecology (Ecology), the U.S. Environmental Protection Agency (EPA), and the U.S. Department of Energy, Richland Operations Office (RL), hereinafter referred to as the Parties, met to determine if the changes proposed to Tri-Party Agreement Major Milestone M-013-00N (Submit 1 200 NPL RI/FS [RFI/CMS] Work Plan for the 200-UR-1, Unplanned Releases Operable Unit) met the "significance" criteria established in the Tri-Party Agreement and associated Community Relations Plan for public involvement. Changes determined to be "significant" must be submitted for public comment. The Parties Public Involvement Officers had previously reviewed the Tri-Party Agreement change package against the criteria and determined that the changes were not significant and did not warrant public review. Therefore, the Class I Tri-Party Agreement change package M-13-03-01, was approved modifying the workscope and due date without going through a public comment period. This determination was formalized and approved by the IAMIT Representatives (attached).

RL and ORP Integrated Discussion of Use of Central Waste Complex (CWC)
