TRANSFER OF F AND H REACTOR BASINS SPENT NUCLEAR FUEL (SNF) TO K BASINS

The U.S. Department of Energy, Richland Operations Office (RL) is proposing that any SNF found during the cleanout of F and H Reactor Basins be transferred to the K Basins for disposition with the existing K Basins inventory. The SNF will be handled in accordance with the current K Basins safety requirements. It is expected that no more than 150 pounds of SNF would be found during the F and H Reactor Basins cleanout.

Since there is no documentation of the acceptance of additional fuel in either the Comprehensive Environmental Response, Compensation and Liability Act of 1980 (CERCLA) Record of Decision or the Remedial Design Report, we are asking that you sign the enclosure as concurrence that this activity is consistent with the K Basins CERCLA Action that has been approved by the U.S. Environmental Protection Agency.
