Attached is the current version of the "Hanford Site Groundwater Protection Management Plan." This version will be updated in accordance with the Federal Facility Agreement and Consent Order Milestone M-13-18A to incorporate (1) the groundwater protection strategy, (2) waste minimization activities, and (3) issues affecting integration of the environmental programs. The revised draft document is to be submitted to the U.S. Environmental Protection Agency (EPA), and the State of Washington Department of Ecology (Ecology) by October 1994.

To support the October 1994, Tri-Party Agreement Milestone, a special request for advance public comment is being made at this time. A brief comment period from June 17, 1994 through July 17, 1994, will be held. The objective of the comment period is to familiarize concerned parties with the document's content and to solicit suggestions for improvement. Because of the limited preparation time to meet the milestone deadline, comments that are extensive in nature may not be addressed at this time. Those comments will be addressed during a second public involvement period that will occur after the revised draft plan has been completed and would be incorporated in the next document revisions.

Please submit comments on or before July 17, 1994, to Mr. R. D. Hildebrand of the Quality, Safety, and Health Programs Division, MSIN: A5-55. Thank you for your participation.
