

Re: Inspection on the Completion Status of Hanford Federal Facility Agreement and Consent Order (HFFACO) Milestone M-48-07 Conducted August 17, 2006

Dear Mr. Schepens and Mr. Spears:

Thank you for the assistance from the United States Department of Energy (USDOE) - Office of River Protection (ORP) and CH2M Hill Hanford Group (CH2M) personnel during the Department of Ecology's recent inspection of the completion status of M-48-07.

Milestone M-48-07, due June 30, 2006, required the completion of work to stabilize, isolate, and monitor miscellaneous tank farm equipment that is not compliant with Washington Administrative Code (WAC) 173-303-640, Tank System Requirements. The purpose of this inspection was to determine whether this work had been completed.

We consider the specific requirements of M-48-07 to have been met; however, we remain concerned with the remaining waste in the catch tanks and the double-contained receiver tanks (DCRT). Collectively, thousands of gallons of liquid and sludge wastes remain in these tanks which violate the standards of WAC 173-303-640. Two of these tanks, ER-311 and UX-302A, are known to have already leaked.

We are currently reviewing the Composite Liquid Mitigation Report (RPP-RPT-31148), submitted to Ecology, on the Catch Tanks and DCRTs, and are assessing the best use for this information. Concurrent with our review of the Composite Liquid Mitigation Report, we advise that USDOE-ORP and CH2M initiate the development of enforceable HFFACO Milestone(s) addressing the removal of waste and closure of the Catch Tanks and DCRTs. A proactive approach to cleanup should be taken before additional tanks develop leaks.
