REVISIONS FOR CENTRAL PLATEAU CLEANUP**


The U.S. Department of Energy Richland Operations Office, U.S. Environmental Protection Agency, and Washington State Department of Ecology thank you for your comments on the October 2015 Tentative Agreement on Hanford Federal Facility Agreement and Consent Order Revisions for Central Plateau Cleanup. Your comments, as well as other comments provided on the proposed changes, were considered and influenced the final revisions to the milestones. Given the magnitude of public comments received and the clear, consistent message, the agencies were able to incorporate these values and concerns by reprioritizing cleanup work, setting clear milestone due dates, and establishing three new milestones.


