Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes

The December 2, 1994, Unit Managers' Meeting Minutes were reviewed and signed by the Unit Managers.

2. Status Action Items:

Status Closure Activities:

WHC (D. M. Korematsu-Olund) stated that RL transmitted the 218 E-8 Borrow Pit Demolition Site Closure Plan (218 E-8), Revision 1, page changes to Ecology on January 17, 1995. Ecology (F. Ma) affirmed that Ecology had received the page changes. RL (E. M. Mattlin) noted that an error occurred during the distribution of the official page changes for both the 218 E-8 and 200 West Area Ash Pit Demolition Site (Ash Pit) closure plan and that the pages changes will be reissued to Ecology this week.

RL (E. M. Mattlin) stated that RL and WHC had concerns with at least two of the permit conditions submitted by Ecology for the Ash Pit and 218 E-8. One of the conditions number V.5.B.e. states that the Permittee and the independent, registered, professional engineer (PE) certifications of closure shall be prepared and submitted to the Department of Ecology within 60 days of closure. Then the Permittee shall continue to address the Ash Pit and 218 E-8 sites as a dangerous waste management unit until receipt of the Department of Ecology's written notification that the sites are accepted as clean closed. WHC (F. A. Ruck) stated that RL was concerned with the order in which the two sentences appear in this permit condition. With the current sentence order, it would require RL and WHC to continue monitoring the sites as dangerous waste management units even though Ecology had accepted the validated data and certification of closure and had agreed that there is no contamination at the sites. There needs to be a formal mechanism in place between RL and Ecology to quickly receive final certification of closure from Ecology. RL would have to continue monitoring a clean site and spending money for inspections, emergency plans, and maintenance until Ecology decided to send written notification that they accept the sites as clean closed. Ecology (F. Ma) understood what was said but needed to discuss this with upper management.

RL (E. M. Mattlin) stated that the second permit condition numbered V.5.B.f. states that the Permittee shall complete the closure activities within 180 days after the effective date of the Permit. RL believes it should read 180 days or the date set by the schedule in the closure plan. Ecology (F. Ma) stated that this would be acceptable if additional time was needed but that they would have to review the permit condition before they could agreed with the change.
