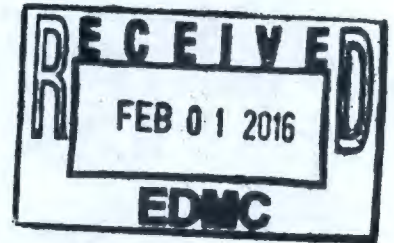

The Agreed Order and Stipulated Penalty Number DE 10156, Reference(2), Exhibit A Section 1.12.1 requires submittal to the Washington State Department of Ecology (Ecology) by the U.S. Department of Energy Richland Operations Office (RL), a Class 3 permit modification request within fourteen months after receipt of the Conceptual Agreement Packages to RL from Ecology.

Attachment 5 provides supporting documentation intended to assist Ecology in review of the Part B Permit Application.


Reference (1) 15-NWP-139, directed "Documentation of the method of storage, the supporting equipment and structures, and the operational procedures for Comprehensive Environmental Response, Compensation, and Liability Act of 1980 K-Basin sludge storage will be added to the T-Plant Facility description." The following statement was included in the T-Plant Process Information addendum:

T Plant also conducts processing and storage of non-dangerous low-level radioactive waste in accordance with the Atomic Energy Act of 1954 (AEA). Management of radioactive waste is not within the scope of the Resource Conservation and Recovery Act of 1976 (RCRA) or WAC 173-303. Any information provided in this document for radioactive waste is for informational purposes only."

A sixty-day public comment period will be held on the permit modification request as required by Washington Administrative Code (WAC) 173-303-830(4)(c)(ii)(A). The notice required by the Permittees in WAC 173-303-830(4)(c)(ii) will be included in the appropriate Hanford Facility Agreement and Consent Order publication or list server, as described in Hanford Facility Resource Conservation and Recovery Act Permit Condition I.C.3. A public meeting is scheduled for March 7, 2016, at 5:30 p.m. per WAC 173-303-830(3)(c)(iv) at the Richland Public Library.
