





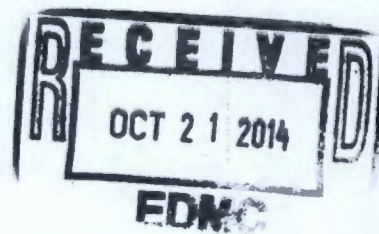
HANFORD FEDERAL FACILITY AGREEMENT AND CONSENT ORDER (HFFACO)
